
Who are Council Members



Membership of the Council

- 1. The SCC shall consist of the following members:
 - a. The commissioner of the department of health and human services, or designee.
 - b. The commissioner of transportation, or designee.
 - c. The commissioner of the department of education, or designee.
 - d. The executive director of the governor's commission on disability, or designee.
 - e. The chair of the New Hampshire Transit Association, or designee.
 - f. A representative of a regional planning commission, appointed by the commissioner of transportation.
 - g. A representative of a philanthropic organization, such as the Endowment For Health or the United Way, appointed by the commissioner of the department of health and human services.
 - h. Eight representatives from transportation providers, the business community, and statewide organizations





Operational Background:

2007- State Coordinating Council (SCC) established by state statute NH divided into eight Regional Coordinating Councils (RCCs) NHDOT contracts with lead agency from each region Lead agency contracts with other service providers within each region as needed to fill gaps





Historically, the NH DOT has been the backbone of SCC development and given communities a reason to come to the table regarding Transportation Development and need

Executive summary:

Directive to Coordinate: The lack of an emphasis for state agencies to coordinate resources has been a major obstacle to creating efficiencies through coordination. Without the requirement to use their funds efficiently across agencies for transportation services, some agencies do not coordinate trips. NH currently has no directive that will encourage efficiency through coordination.

The SCC believes the Commissioner of the New Hampshire Department of Health and Human services should designate a staff member to attend New Hampshire Statewide Coordinating Council meetings





2019-20 Annual Report

Executive Summary:

Since our last report, the Commissioner of New Hampshire Health and Human Services (DHHS) has appointed staff to the SCC... Additionally, the Commissioner nominated a member of the philanthropic community to participate with the SCC. This is a significant change and achieves a full Council for the first time in many years....... the Governor and Legislature can assist the SCC in reaching its goals by **Supporting, developing, and approving legislation that mandates state departments and agencies to utilize and further develop the coordinated community transportation structure** that has been in development for the last decade.



- NH DHHS was awarded a CDC's COVID Health Disparity Grant!
- NH DHHS -
 - That itself was largely due to SCC outreach to Public Health
- Recognized synergy with CDC grant
- Worked with SCC and others to secure grant funds
- \$3M over two-year period
 - Enables full-time Regional MM positions and demonstration money in Rural Areas
- Additional regional & statewide projects envisioned
