


The Power of Design Thinking

The Goal: Solution "Sweet Spot"



Key ideas behind design thinking

- DT is an honest process
- DT requires developing empathy with all your "customers" co-creation
- DT solutions are grounded in your research—not your own guesses or intuitions or "the way we've always done it"
- DT solutions are created by partnerships representing all stakeholders and especially including perspectives different from your own
- DT is built around testing to learn to de-risk your solution

- * Please complete a report for every month, even if you are not seeking reimbursement of any costs.


Monthly Reporting Requirements **Budget Modifications**

- Why: The design challenge process is iterative and requires flexibility we want to make sure your budget can be adjusted as your project does
- How: Submit budget modification requests to <u>king@ctaa.org</u> and <u>conrick@ctaa.org</u>
- When: Need to have a budget modification request submitted at least 1 week
 prior to your monthly report submission to allow time for NCMM staff to consider
 your request


