WHO ARE AFFORDABLE HOUSING PROVIDERS?

- HUD and USDA are the primary providers of housing assistance to low- and very-low-income Americans.
- Assistance can be provided through vouchers or through place-based subsidies to affordable housing providers.
- More than half of HUD Public Housing units are headed by an older adult and HUD has a flagship program Section 202, specifically for individuals who are ages 62+ and/or disabled.
- Many Section 202 affordable housing sites have service coordinators to assist residents to meet their basic needs, including transportation.

SERVICE COORDINATORS IN AFFORDABLE HOUSING

 Connect residents to services and resources to assist them with aging well in their communities

 5,000+ HUD Section 202 properties for older adults with service coordinators

 500 Public Housing sites serving families with self sufficiency service coordinators




TRANSPORTATION ACCESS IN AFFORDABLE HOUSING

Residents are very low income and as a result less likely to have access to reliable personal transportation

- Average income in HUD senior housing is \sim \$1,000/month
- 50% of Area Median Income is what most Public Housing residents earn annually

Lack of transportation can lead to reduced opportunities and social isolation

Average number of residents per HUD Senior Housing Property is 1.1 per unit

Who We Serve: Demographics


Two in five seniors in San Diego County can't afford basic needs - rent, food, healthcare and transportation.


Seniors Served 10,765



Median Income \$1,125/month


Below the Federal Poverty Level

Transportation = Access to...


- More than getting from A to B
- Food, doctors, family, community, shopping, exercise, and case management
- Self-sufficiency
- Independence & dignity
- Overall quality of life



The Cost and Impact of Inaccessibility

- Missed medical appointments
- Poor nutrition and food insecurity
- Loss of independence
- Social isolation and loneliness
- Increased ER use
- Earlier entry into long-term care

Social isolation is as bad for your health as smoking.





What's Needed

"5 A's of Senior-Friendly Travel"

- Availability transit exists and is available when needed
- Accessibility can be reached and used
- Affordability fees are affordable
- Acceptability clean, safe, and user-friendly
- Adaptability can be modified or adjusted for special needs

How We've Tried to Meet the Need

- Build affordable housing and senior wellness centers on or near transit lines
- Access to free shuttle service vouchers in downtown San Diego
- Offer free bus passes
- Establish taxi accounts
- Provide door-through-door transportation service
- Utilize ride-share options
- Access Medi-caid Managed Care plan transportation benefits



Transportation as a Social Determinant of Health (SDOH)

- Intersects with housing, food security, medical care, and community belonging
- Transportation is the "connective tissue" that holds it all together
- Health equity and housing stabilization require transportation options



Closing and Call to Action

- Transportation access drives equity
- Partner early and often in planning, funding, and policy
- Explore other models AARP Age-Friendly Communities & 8 80 Cities








Figure 1, "Transport and Mobility Needs for an Ageing Society from a Policy Perspective: Review and Implications", Dong Lin, Jianqiang Cui, International Journal of Environmental Research and Public Health, November 2021.




Aging Population Overview



- The world population is ageing, presenting significant challenges for health and social systems.
- ❖ Mobility is closely linked to independence, wellbeing, and quality of life for individuals.
- ❖An ageing population poses long-term challenges for various aspects of nations, including transport.
- ❖ Major concerns have emerged about how future policies can effectively respond to the mobility needs of older adults.
- ❖ Transport and housing planners, operators, and decision-makers are focused on delivering effective mobility solutions for an ageing population.
- *Emphasis on providing accessible, safe, and affordable transport options near affordable housing for older adults.

Why is it Important for Transportation to be in Close Proximity to Housing for Older Adults



Access to Healthcare

❖ Older adults often have increased medical needs. Living near reliable transportation helps them reach doctors, clinics, pharmacies, and hospitals without relying on others.

Independence and Autonomy

❖ Transportation access enables older adults to maintain their independence, reducing isolation and increasing their ability to manage errands, attend events, and stay socially connected.

Improves Safety and Mobility

❖ Older adults are at greater risk for injury as pedestrians. Welldesigned, transit-rich areas are safer than car-dependent areas due to better sidewalks, crossings, and lighting.

Why is it Important for Transportation to be in Close Proximity to Housing for Older Adults



Reduced Financial Burden

Many older adults live on fixed incomes. Proximity to public transit reduces the need for car ownership or expensive ride services, which helps manage limited budgets.

❖ Social Engagement and Mental Health

❖ Easy transportation options encourage participation in community activities, social groups, and religious services, which can combat loneliness and improve mental well-being.

Access to Essential Services

❖ Being near transit hubs allows older adults to reach grocery stores, government services, and other essential amenities that may not be within walking distance.

Why is it Important for Transportation to be in Close Proximity to Housing for Older Adults



❖Support Aging in Place

❖ Affordable housing with good transportation links allows older adults to age in place rather than move into institutional care, preserving comfort, familiarity, and dignity.

❖Advances Equity and Inclusion

- Aligns with age-friendly, ADA-compliant, and equitable transportation goals.
- Ensures older adults are not left behind in planning and development.

















Research: Locating Affordable Homes Near Transit

Low Income Households Near Transit v. Not Near Transit:

- Drive 25-30% fewer miles
 when ½ mile from transit
- Drive 50% fewer miles
 when ½ miles from transit

Higher Income Households

 Twice as many miles and vehicles compared to Low Income Households






Transit Agency Land




